About This Conference

This conference is the third biennial conference on teaching legal writing. The conference, which is sponsored by the Legal Writing Institute, is designed for people who teach legal writing and for people who administer legal writing programs.

During the first half of the conference, the focus will be on the teaching of legal writing. Participants can select from among sessions and workshops on designing an effective curriculum, designing effective writing assignments, evaluating student papers, and teaching effectively. During the second half, participants will attend sessions that cover current research and issues in legal writing.

The conference will be held on the campus of the University of Puget Sound, in Tacoma, Washington. Among its activities will be a picnic on August 4th; a ferry trip and dinner in Seattle on August 5th; and an optional trip to Mount Rainier on August 6th. The University of Puget Sound is located in the heart of the Pacific Northwest, an excellent site for a vacation. Mount Rainier, Mount St. Helens, the San Juan Islands, Victoria, B.C., and Vancouver, B.C., all lie within a few hours' drive of the University.
